Deepthi Jeevanji 2024 Paralympics Winner (Bronze Medal ,400m T20)



We at ICCL India Foundation (ICCL-IF) are delighted and honored to have supported our Deepthi Jeevanji Para Athlete's successful journey. Deepthi has continued to inspire many, by winning 2024 Paralympics-Paris a Bronze Medal in the Women's 400m T20 final race. It is worthwhile to note that Deepthi is the first intellectually impaired Indian athlete, to win a Paralympic medal.



Deepthi comes from a very remote small village (Kallada, Warangal District), Telangana State. She was born to a daily-waged labour parents, working at other's farms. She suffered from an intellectual disability right from her childhood and faced significant challenges, insults/mockeries in the society.

Villagers urged her parents to abandon her due to her features and to send her to an orphanage. Deepthi's parents (Jeevanji Yadagiri and Jeevanji Dhanalaxmi) who stood by her through thick and thin, never ceased in supporting and encouraging their daughter.



Deepthi knows only 'How to Run' and the Running is her life. Unmindful of her drawbacks and setbacks, she has shown to the world's sports lovers that nothing is bane or a hurdle to achieve determined goals through vigorous efforts and toil.

Deepthi's talent was spotted by her school PET teacher and later came under coach N Ramesh (Indian coach for Junior Athletics team) when she was 15yrs old.

Pullela Gopichand (former Indian Badminton player and now chief national coach) observed her relentless hard work and progress supported Deepthi and tested her at the National Institute for the Empowerment of Persons with Intellectual Disability, Hyderabad. Here, she was certified under the mentally impaired category and allowed to participate as a Para-athlete.

ICCL India Foundation (ICCL-IF) shall continue to support her as she moves forward in achieving many more laurels to India and inspiring our next generation talented para-athletes and our communities for more inclusion and prosperity.

The Paralympic Committee of India (PCI) is the apex governing body dedicated to promoting and developing Para Sport in the country. PCI is affiliated with the International Paralympic Committee (IPC) and recognised by the Ministry of Youth Affairs and Sports (MYAS), Government of India, as a National Sports Federation.

Our mission is to identify, train and support athletes across the country, nurturing a dynamic Paralympic movement and ensuring strong representation in both national and international sports events.

The New Delhi 2025 World Para Athletics Championships, scheduled to take place from 27 September to 5 October at Jawaharlal Nehru Stadium, which will welcome participants from over 100 countries, making it the largest-ever Para sport event hosted in India.



Special Olympics Bharat is a National Sports Federation and is accredited by Special Olympics International to conduct Special Olympics Programs in India. It is recognized by the Ministry of Youth Affairs & Sports, Government of India as a National Sports Federation in the Priority Category, for development of Sports for Persons with Intellectual Disabilities, and is a designated Nodal Agency for all

disabilities on account of its national presence and experience, especially in rural areas which account for nearly 75 per cent of the disabled population in India.

World Para Athletics is the biggest sport within the Paralympic Movement in terms of the number of participating athletes and countries. Today World Para Athletics, under the governance of the International Paralympic Committee (IPC), acts as the international federation for the sport.



The Paralympic Games are the pinnacle globing sporting event for Para athletes, showcasing the very best of Para sport, and providing optimal conditions for a diverse group of Paralympic athletes to achieve excellence. The next Paralympic Games will be held in Los Angeles (LA, USA) in 2028 followed by Brisbane, Australia



in 2032. The next winter edition will be staged in Milan and Cortina in 2026 with the French Alps to follow in 2030 and Salt Lake City in 2034.

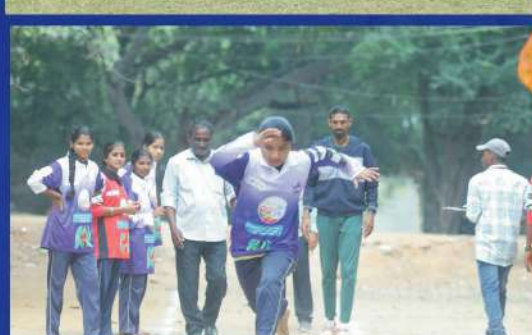

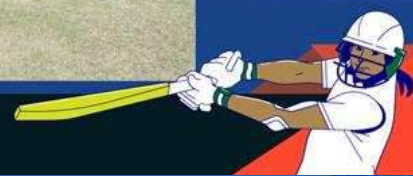
